

## **2019 PSEG Long Island \$1,000 Website Trivia Sweepstakes Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT IMPROVE YOUR CHANCES OF WINNING. OPEN ONLY TO LONG ISLAND CUSTOMERS SERVICED BY PSEG LONG ISLAND AS OF December 1, 2019 WHO ARE 18 YEARS OF AGE OR OLDER AS OF THE DATE OF ENTRY.**

### **1. Eligibility**

The 2019 PSEG Long Island \$1,000 Website Trivia Sweepstakes (the "Sweepstakes") is open only to persons who are (18) years of age or older at the time of entry. Entrants must be a Long Island customer serviced by PSEG Long Island as of December 1, 2019 and must be a PSEG Long Island customer in good standing at the time of the drawing. Employees, independent contractors, and any other persons or companies who receive compensation from PSEG Long Island ("Sponsor") or its affiliates and/or Long Island Power Authority or its affiliates and the immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of all such persons are not eligible to participate in this Sweepstakes. Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to, and acceptance of, these Official Rules. Winning a prize is contingent upon fulfilling all requirements set forth herein.

### **2. Sweepstakes Entry Period**

Sweepstakes begins on the first day of the month at 12:01 a.m. Eastern Time and ends the last day of the month (each "Sweepstakes Entry Period"). The Sweepstakes will continue indefinitely each with a new Sweepstakes Entry Period. The Sponsor in its sole discretion can terminate the Sweepstakes at any time at the end of a Sweepstakes Entry Period.

### **3. How to Enter**

Logging on to [www.psegliny.com](http://www.psegliny.com) and log in. Then you will have to navigate to the Trivia section where you will see four (4) short question quiz. You will be asked to complete all four questions as well as to provide a current mailing address and email address. Once you complete this, you will automatically be entered into the Sweepstakes. Limit of one entry per profile completed, per residential PSEG Long Island account during each Sweepstakes Entry Period. Participants do not have to score all four questions correct, to be eligible for the drawing. You are not permitted to share the same PSEG Long Island account with another entrant. Use of any automated system to enter is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries all of which will be ineligible to win a prize. Potential winner may be required to show proof of being the authorized PSEG Long Island account holder to be awarded the prize.

### **4. Monthly Winner Determination**

Approximately two days after the Sweepstakes Entry Period the Sponsor will select five (5) entries for the grand prizes described below in a random drawing of all valid entries received. Odds of winning depend on the number of eligible entries received during the monthly Sweepstakes Entry Period. The potential Sweepstakes winner will be contacted using their email or phone number provided or that PSEG Long Island has on file for that account and may be awarded the prize. Failure by potential Sweepstakes winner to respond to the initial verification within five (5) days of notification will result in disqualification and Sponsor will select an alternate potential Sweepstakes winner in the same manner.

**5. THE POTENTIAL SWEEPSTAKES WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES. MUST BE A PSEG LONG ISLAND CUSTOMER IN GOOD STANDING AT THE TIME OF THE DRAWING.**

**6. Verification of Potential Winners**

The potential prize winners must continue to comply with all terms and conditions of these Official Rules and the awarding of a prize is contingent upon fulfilling all requirements. The potential prize winners will be required to complete, within ten (10) days of the date notice is sent, an affidavit of eligibility in order to claim his/her prize. If a potential winner cannot be contacted, fails to complete the affidavit of eligibility within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, the potential winner is disqualified and forfeits the prize. If a potential winner of a Sweepstakes prize is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.

**7. Monthly Grand Prizes**

Five (5) grand prize will be awarded each month. Each grand prize winner will receive a one thousand-dollar (\$1,000) MasterCard gift card. No cash equivalent for the prize, prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the listed prize for one of equal or greater value for any reason. Winner is responsible for all taxes and fees associated with prize receipt and/or use. All federal, state, and local tax liabilities, as well as any other costs and expenses not specified herein as being awarded are the sole responsibility of the Winner. Prize will be awarded only if the potential prize winner fully complies with these Official Rules.

**8. Entry Conditions and Release**

By entering, each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Sponsor and its respective parent, subsidiary, and affiliated companies, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes, and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Sweepstakes, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Sponsor from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize.

**9. Publicity**

Except where prohibited, participation in the Sweepstakes constitutes each potential winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration.

**10. General Conditions**

Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures or any other factor impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Sponsor reserves all its rights against any person or entity that attempts to deliberately undermine the legitimate operation of the Sweepstakes. Sponsor's failure to enforce any term or any provision of these Official Rules shall not constitute a waiver of that term or provision.

#### **11. Limitations of Liability**

The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (b) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Sweepstakes; (d) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; or (e) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes. No more than the stated number of prizes will be awarded.

#### **12. Disputes**

Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate New York State Court located in the New York County, New York; (c) any and all claims, judgments and awards shall be limited to reasonable actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but shall in no event include attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and waives any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any choice of law or conflict of law rules (whether of the State of New York or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of New York.
