

## Pool pump rebate requirements

- ✓ Must be a new **ENERGY STAR Certified Variable-Speed Pump**, 1/2 horsepower or larger and currently listed on the ENERGY STAR certified list.

## Electric heat pump pool heater rebate requirements

- ✓ Heat pump must be new and have a coefficient of performance (COP) of at least 5.
- ✓ Beginning in 2021, limit of one heat pump pool heater per residential customer account every 5 years.

## General rebate requirements

- ✓ Both electric heat pump pool heaters and ENERGY STAR Certified pool pumps **must be installed by a participating dealer/installer** who has completed the 2021 Letter of Agreement and obtained a manufacturer's training certificate. A complete installer list is located on the PSEG Long Island website, at **PSEGLINY.com/efficiency**.
- ✓ Must be a PSEG Long Island residential customer with address in the N. Bellmore Super Savers program area. See the project area map and learn more at [psegliny.com/supersavers](http://psegliny.com/supersavers)
- ✓ **Purchase date and installation date must be in calendar year 2021 and postmarked no later than December 31, 2021.**
- ✓ The rebate amount cannot be more than 50 percent of the retail purchase price paid.
- ✓ All measures must carry the appropriate designated Underwriters Laboratory (UL) or Electrical Testing Laboratory (ETL) label.
- ✓ All installations must be installed in accordance with all applicable local, state and national codes and ordinances.
- ✓ **For all purchases made online**, please provide a paid receipt as well as Proof of Delivery/Pickup with application submission.
- ✓ **All rebate submissions are subject to post inspection.**

## Rebate documents for submittal

- ✓ A copy of dated sales receipt/paid invoice showing manufacturer, model number, installation date and purchase price.
- ✓ All customer, installer and product information must be completed in full.
