RE: 2025 Commercial Program Updates

Effective Monday, November 17, 2025, we will no longer be accepting new applications for non-strategic measures requiring pre-approval. Fast track applications may be submitted until December 1, 2025 at 5PM (EST).

Non-Strategic Measures

Custom	Plug Load/Plug Load Management Horticultural Lighting Indoor & Outdoor Lighting, Lighting Controls Air Conditioning Systems, Coil Cleaning UV Lamps
Lighting	Indoor & Outdoor Lighting
Refrigeration	Strip Curtains, Night Covers, Door Gaskets, Ice Maker, LED Lighting, Lighting Controls
Standard	HVAC Motor Belts, VFDs, Elevator Modernization, EC Motor: Hydronic Circulator Pump
Water Heater & Conservation	Pre-Rinse Spray Valves, Clothes Washer, Clothes Dryer, Salon Valves, Low Flow Faucet, Low Flow Showerhead
HVAC	All Central Air Conditioners and Cooling Only Equipment

If the measure is not listed above, the measure will continue to be eligible for a rebate in 2026 and applications will continue to be accepted. Please note, if you have a Custom Chiller project, consult your PSEG Long Island representative to discuss measure eligibility.

This is a final reminder that any open PSEG Long Island Commercial Efficiency Rebate project type* must have all Closing Documents submitted no later than Monday, December 1, 2025, by 5:00 PM (EST).

*Project types include Interior and Exterior Lighting, Refrigeration Measures (Strip Curtains, Night Covers, Door Gaskets, Ice Maker, LED Lighting and Controls), Standard Measures (HVAC Motor Belts, VFDs, Elevator Modernization, EC Motors, Hydronic Circulator Pumps), HVAC (All Cooling Only equipment)
