 - Projects are continuing to be processed as before

- Clean up older projects
 - Work with your Energy Consultants to clean up any projects that are on hold for missing documents or information

 - We will be extending pre-approvals for projects that were set to expire between March 16 and NYS on Pause Order to August 31.
 - Any project that had expired prior to March 16 will be paid out on the new worksheet. (v1.1)
