## RE: 2022 Technical Assistance Program Update

### Energy Efficiency Program Participants:

PSEG Long Island is happy to announce the following updated to the 2022 Commercial Efficiency Program (CEP) Technical Assistance (TA) Energy Engineering Study Application. Below please find the list of application updates effective 8/13/2022.

- 2022 Technical Assistance Energy Engineering Study Application – ASHRAE Level II Audits
  - Account must be rate code 285
  - The ASHRAE Level II Audit program will provide a 2 phase payment structure for customers/TA Partners
    - Phase 1: At the completion of the study, PSEG Long Island will rebate the customer or TA Partner **90% of the cost of the study**. (See next bullet for rebate caps)
    - Phase 2: After the completion of the recommendations in the study, PSEG Long Island will rebate the customer or TA Partner the additional **10% of the cost of the study**.
  - Maximum Rebate will be capped based on building size:

Building Size (sqft)	Rebate Cap
<100,000	\$25,000
100,000-249,999	\$35,000
250,000-499,999	\$50,000
>500,000	\$80,000

- Audit(s) must be completed per ASHRAE standards, as well as PSEG Long Island requirements, including ENERGY STAR benchmarking, on-site data collection, energy saving calculations, energy conservation measure recommendations, and detailed executive summary
- **Please note, a PSEG Long Island Preapproval Letter must be obtained prior to starting study**
- 2022 Technical Assistance Energy Engineering Study Application – All Studies
  - All approved Technical Assistance Energy Engineering Studies will provide a 2 phase payment structure for customers/TA Partners
    - Phase 1: At the completion of the study, PSEG Long Island will rebate the customer or TA Partner **90% of the cost of the study**. (See next bullet for rebate caps)
    - Phase 2: After the completion of the recommendations in the study, PSEG Long Island will rebate the customer or TA Partner the additional **10% of the cost of the study**.
  - Rebates will be capped at \$50,000
  - **Please note, a PSEG Long Island Preapproval Letter must be obtained prior to starting study**

For Reference, here's how ASHRAE defines Level I, II, and III Energy Audits:

- **Level I:** Site Assessment or Preliminary Audits identify no-cost and low-cost energy saving opportunities, and a general view of potential capital improvements. Activities include an assessment of energy bills and a brief site inspection of your building.
- **Level II:** Energy Survey and Engineering Analysis Audits identify no cost and low-cost opportunities and provide EEM recommendations in line with your financial plans and potential capital-intensive energy savings opportunities. Level II audits include an in-depth analysis of energy costs, energy usage and building characteristics and a more refined survey of how energy is used in your building.
- **Level III:** Detailed Analysis of Capital-Intensive Modification Audits (sometimes referred to as an “investment grade” audit) provide solid recommendations and financial analysis for major capital investments. In addition to Level I and Level II activities, Level III audits include monitoring, data collection and engineering analysis.

Unless indicated above, there are no additional changes to applications.
