## RE: 2022 Second Quarter Commercial Program Updates

PSEG Long Island is happy to announce updates to the 2022 Multi-Family Program and 2022 Commercial Efficiency Program. Below please find the list of application updates that are effective May 16, 2022:

### 2022 Multi-Family Program

- 2022 Multi-Family Rebate Application Version 2.0
  - New Measures:
    - Energy Star Clothes Washers
      - Rebate \$40/Unit
    - Bundled Appliances
      - Energy Star Clothes Washers + Energy Star Refrigerators
        - Rebate: \$70/Bundle
          - Clothes Washer + Refrigerator must be purchased to qualify
      - Energy Star Clothes Washers + Energy Star Dishwashers
        - Rebate: \$70/Bundle
          - Clothes Washer + Dishwasher must be purchased to qualify
      - Energy Star Clothes Washers + Energy Star Refrigerators + Energy Star Dishwashers
        - Rebate: \$100/Bundle
          - Clothes Washer + Refrigerator + Dishwasher must be purchased to qualify
    - In-Unit HVAC: Eligibility Criteria and Rebate Levels
      - Eligibility criteria adjusted to allow all NEEP-listed cold climate heat pumps to qualify for Whole Unit and Partial Unit rebates
      - All Whole Unit rebates adjusted to \$1,000/12,000 heating BTU
      - Rebate categories streamlined for Whole Unit projects
- 2022 Multi-Family Eligibility Table Version 1.0
  - All eligibility tables have been removed from the Multi-Family Application and are now available in the standalone 2022 Multi-family Eligibility Table Version 1.0.

### 2022 Commercial Efficiency Program

- 2022 Geothermal Application v2.0
  - Income-eligible residential customers can now receive increased rebate per ton. This offering is for residential customers only and commercial customers do not qualify.
