**RE: 2022 Commercial Contractor Incentive Program**

Energy Efficiency Program Participants:

PSEG Long Island’s Commercial Efficiency Program (CEP) is happy to announce a **limited time Contractor Incentive Program where our partners can earn an incentive of 15% to 25% of the projects’ rebate amount**. This program goes into effect March 1<sup>st</sup>, 2022 and is expected to last through 12/1/22. See details below and on the Contractor Incentive Application.

**CEP Contractor Incentive Program**

Effective March 1, 2022, through December 1, 2022, all contractors who start and complete a minimum of 10 CEP projects and submit all Required Closing Documents by the “Project Completion Deadline” may qualify for a **Contractor Incentive**. Contractor Incentives are broken down into three different tiers and are based upon percent of final customer rebate. Contractors will receive the Contractor Incentive based on the completion date of their tenth project. If a contractor completes 10 projects, the contractor will qualify for the tier in which the tenth project was completed. If more than 10 are completed, those subsequent projects will qualify for the Contractor Incentive in the tier in which they are completed.

To Qualify for the Contractor Incentive, the contractor must:

- Complete the “Contractor Incentive Program Application” and “Contractor Incentive Project Log”
  - These documents must be submitted through the PSEG Long Island Lead Partner Portal by the “Contractor Incentive Application Submittal Deadline” for the qualifying Incentive Tier
    - Submittals through the CEP Mailbox will be rejected
- Be listed on all qualifying applications as contractor of record

- Submit a valid W-9
  - Submit all closing documents by “Project Completion Deadline” date for qualifying Incentive Tier
    - If project is not complete, contractor will forfeit incentive and be subject to Quality Control Evaluation (QCE) Process

Please note, for the purpose of this program, if more than one project for one application type is completed at a facility, those multiple projects will count as one project. All projects are subject to post-inspection. Eligible projects must have applications signed and dated by the customer on or after 3/1/22. The minimum Customer Rebate per projects is \$1,000. Projects with a total rebate value less than \$1,000 do not qualify.

Please continue to utilize the Lead Partner Online Application to enter applications and upload project documents. The Online Application can be found in the existing Lead Partner Portal under the “Your Dashboard” view. If applications are submitted through the Lead Partner Portal Online Application, it is not necessary to e-mail the Application and Required Documents to the Commercial Efficiency Program Mailbox.
