## **Terms and Conditions**

The Partner shall observe the following to retain a good relationship with PSEG Long Island:

If so, list all individuals on the Application, as this is an ongoing requirement.
- The Partner acknowledges that participation in PSEG Long Island's Energy Efficiency Programs is a privilege, and that PSEG Long Island may suspend or terminate Partner's participation in PSEG Long Island's Energy Efficiency Programs for any reason, including failure to maintain program standards. In all cases involving a Partner's participation status, PSEG Long Island's written decision is final.
