

# Standby Rates

Designed for customers with on-site generation



Effective January 1, 2026, Standby Rates are mandatory for certain commercial and industrial customers whose electricity requirements are partly self-supplied through on-site generation.\* They are optional for all other customers.

When a customer operates on-site generation to serve their own electric load, PSEG Long Island is required to "standby" and provide 24/7 back-up power to serve that load in the event the customer's generation fails or is taken down for maintenance. That often involves installing and maintaining energy infrastructure solely to meet that customer's needs.

Standby Rates, in place throughout New York State, better align a utility's cost for this service with revenue recovered and prevent shifting those costs to other customers.

In addition to power supply charges and other surcharges, they consist of the following charges:

<b>Monthly Customer Service Charge</b>	A fixed amount that does not vary based on usage
<b>Delivery Service Contract Demand Charge</b>	Per kW of Contract Demand. This is a reservation charge for the use of the Company's local distribution system initially set at the maximum anticipated demand of the customer
<b>As-Used Daily Delivery Service Demand Charge (Peak)</b>	Per kW of daily peak demand during peak hours (3 PM to 7 PM, weekdays, excluding federal holidays)
<b>As-Used Daily Delivery Service Demand Charge (Off-Peak)</b>	Per kW of daily peak demand during off-peak hours (all hours outside peak hours, including weekends and federal holidays)
