RE: 2025 Commercial Program Updates

On August 1, 2025, we announced (see Program Announcement CEP 2025-03) new measures that were identified as "Non-Strategic*". Based on *new and additional* guidance from New York State through the New Efficiency: New York order, PSEG Long Island would like to announce the following changes to the Commercial Efficiency Portfolio. All measures identified as "Non-Strategic" will be discontinued as per the table below. All updates are in orange.

Any 2025 program measures currently offered in the Commercial Efficiency Program, that are not listed above, will continue to be eligible for rebates in 2026. Please note, if you have a Custom Chiller project, consult your PSEG Long Island representative to discuss measure eligibility.

General Note: For all newly identified measures in the above table (in orange), existing pre-approvals will be honored. For all new projects, project must be completed and closing documents submitted by December 1, 2025. If you're unsure if your measure is considered "Non-Strategic", please contact your PSEG Long Island representative for more information.

*Non-Strategic Definition:

- Naturally occurring EE that results from codes & standards or routine market adoption
- Increase use of fossil fuels
- Jeopardize advancement of strategic EE/BE programs/measures
- Have an effective, useful life of 6 years or less
