PSEG Long Island is happy to announce the 2024 Commercial Efficiency Program (CEP). Below please find the list of applications effective November 6th, 2023.

Effective immediately (November 6th, 2023), we will not accept any 2023 Multifamily or Custom Applications

For all other applications, we will continue to accept 2023 applications through Wednesday, November 15th, 2023, at 5:00 PM. After this date we will not accept any 2023 applications.

2024 Commercial Efficiency Program Applications:

- 2024 Comprehensive Performance Lighting Application Version 1.0
 - Measure Rebates (other than Lamps and Tubes) reduced from \$0.30/kWh to \$0.22/kWh
- 2024 Fast Track Lighting Version 1.0
 - Rebate Cap Adjusted to \$5,000
- 2024 Geothermal Rebate Application Version 1.0
 - Updated Commercial Geothermal Rebate Cap → 70% Cost Cap or \$50,000 rebate cap, whichever occurs first
 - Added clarifying language regarding Open Loop Systems and additional requirements
- 2024 Standard Rebate Application Version 1.0
 - Removed all Kitchen Equipment in accordance with NYS Appliances Standards effective June 26th, 2023
- 2024 Multi Family Rebate Application Version 1.0
 - Removed rebates for appliances and in-unit lighting
 - Application updated to emphasize Custom Multi Family Heat Pump installations
 - New Construction Heat Pumps/VRFs → \$500/Dwelling & \$100,000 Rebate Cap Per Building
 - Existing Building Heat Pumps/VRFs → \$1,000/Dwelling & \$200,000 Rebate Cap Per Building
 - In-Unit ENERGY STAR Heat Pump Water Heaters → \$1,000/Unit
- 2024 Custom Performance Rebate Application Version 1.0
 - Application updated to emphasize all Commercial Heat Pumps
 - New Construction* → \$50/MMBTU & \$100,000 Rebate Cap Per Building
 - *Includes electric replacements and supplemental heating scenarios
 - Decommissioning Fossil Fuel → \$120/MMBTU & \$200,000 Rebate Cap Per Building
 - Building Weatherization w/ HP Installation → \$100/MMBTU
 - For Multi Family Heat Pumps please use the 2024 Multi Family Rebate Application Version 1.0
- 2024 Technical Assistance – Engineering Study Application Version 1.0
 - Cost Study Cap updated from 90% to 50%
 - Updated Tier I and Tier II Rebate Cap to \$20,000
- 2024 Technical Assistance – LEED Application Version 1.0
 - Cost cap adjusted from 70% to 50%
- 2024 Technical Assistance – Whole Building Application Version 1.0
 - Energy Model Cost Cap updated from 90% to 50%
 - Whole Building Cost Cap updated from 70% to 50%
