

2023 PSEG Long Island Recycling VISA Gift Card SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT IMPROVE YOUR CHANCES OF WINNING. OPEN ONLY TO LEGAL RESIDENTS OF LONG ISLAND, NEW YORK WHO RESIDE IN LONG ISLAND POWER AUTHORITY'S SERVICE TERRITORY AND WHO ARE 18 YEARS OF AGE OR OLDER AND ARE PSEG LONG ISLAND CUSTOMERS. - 1. Eligibility: The 2023 PSEG Long Island Recycling VISA Gift Card Sweepstakes ("Sweepstakes") begins at 12:01 a.m. CDT on May 15, 2023, and ends at 11:59:59 PM CDT on July 15, 2023 (the "Sweepstakes Period"). Appliance must be collected by August 15, 2023, in order to qualify as an entry for the sweepstakes. The Sweepstakes is open only to persons who are (18) years of age or older at the time of entry. Entrants must be PSEG Long Island customers in good standing during the entire Sweepstakes Period and at the time of the drawing. Employees, independent contractors, and any other persons or companies who receive compensation from ARCA Recycling, Inc. (ARCA) 7301 Ohms Lane, Suite 320, Edina, MN 55439 or PSEG Long Island and the immediate family (spouse, civil union/domestic partners, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of all such persons are not eligible to participate in this Sweepstakes. Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to, and acceptance of, these Official Rules. Winning a prize is contingent upon fulfilling all requirements set forth herein.

Eligible participants will receive one automatic entry per account entries are not tied to the number of appliances recycled. Or (ii) complete a 3" x 5" postcard, and mail it in a standard envelope with proper postage to:

The postcard must include your First Name, Last Name, Street Address, City, State, ZIP, Phone Number, and PSEG Long Island Customer Account Number. Mail-in entries must be postmarked no later than July 15, 2023. Participating in the PSEG Long Island Appliance Recycling Program will not increase your chances of winning. Limit one (1) entry per PSEG Long Island residential account number, regardless of

method of entry. In the event that multiple entries are received for the same PSEG Long Island account number, the authorized account owner at the time of entry will be considered the entrant. All entries become the property of PSEG Long Island and will not be acknowledged or returned. By entering, entrants acknowledge compliance with these Official Rules, including all eligibility requirements.

- 3. Random Drawing: Two (2) Grand Prize Winners will be selected in a random drawing from all eligible entries received on or about September 10, 2023. The drawing will be conducted by ARCA Recycling, Inc., 7301 Ohms Lane, Suite 320, Edina, MN 55439. Two winners will be selected, one from Suffolk County, one from Nassau County. Winners will be notified by phone or email on or about September 15, 2023. Failure to respond to the initial verification within (10) days of notification will result in disqualification and selection of an alternate potential winner in a random drawing of all remaining valid entries received. PSEG Long Island's decisions as to the administration and operation of the Sweepstakes and the selection of the potential winner are final and binding in all matters related to the Sweepstakes.
- 4. Prizes/Odds: Grand Prize (2): \$500 VISA gift card. Odds of winning depend upon the total number of entries received. Two winners will be selected, one from Suffolk County, one from Nassau County.

Limitations of Liability: Sponsor and its agents are not responsible for any incorrect or inaccurate information, whether caused by entrants, printing errors, or by any of the equipment or programming associated with or used in the Sweepstakes.
