RE: 2026 EV Make Ready Updates

PSEG Long Island is pleased to announce that we are now accepting applications for 2026 EV Make Ready projects including Level 2 and DC Fast Chargers. Effective as of the announcement date the new application workbook is available (PSEG LI_2026 Electric Vehicle Make-Ready Application_VERSION 1.0). We will no longer accept 2025 applications.

Please note, as mentioned in previous program announcements, funding is limited for 2026 for DC Fast Chargers. PSEG Long Island will be accepting application submissions and pre-approving them in the order that they are received until funding is expended. Once funding is expended, a program announcement will be made. We will be working with LIPA to identify other potential sources of DCFC funding for 2026.

2026 Program Updates:

- Tiers 50%-75%-100% have been replaced with Tier 3, Tier 2, and Tier 1, with Tier 1 representing the highest incentive available
- The Rate Code field now has a drop-down field for Applicants to select from
- New Facility Type fields have been added
- Removed non-relevant questions under the Site Information tab
- The DCFC Lease Model and USMR Coverage Only have been removed. Both Level 2 and DC Fast Chargers will receive a cash rebate
- Future Proofing Costs have been removed from the Make Ready Costs tab
- Multi-Family projects are capped at \$100,000 per site, and are subject to the Eligibility Tiers, specifically regarding accessibility and DAC status.

Incentives have not changed since the last program announcement with the incentive structure as follows:
