RE: 2022 Home Comfort and Home Performance Program Application Version 1.0 Release

Dear Home Comfort Partners:

PSEG Long Island is pleased to announce the 2022 Home Comfort Program and release of the 2022 Home Comfort and Home Performance rebate application workbook. Effective Saturday, January 15th, all new project submittals must use the 2022 application. The application is now available for download at

As with every program year, there are some changes to be aware of for 2022 Home Comfort Program. The good news is the changes are minimal when compared to previous years. You will find the rebates and minimum efficiency requirements have remained the same, however there have been some changes to the Post Project Completion Form and Assignment Form and where they are located.

We have made minor changes the 2022 rebate application. To help track the ASHP (and controls/thermostat) costs, we have added the Heat Pump Cost worksheet. Please include total installed cost per system. Installed cost should include equipment, labor, ancillary work required for the installation, fees, taxes, etc. It should exclude any costs that are NOT associated with the project, and it should exclude the rebate.

The Post Project Completion Certification Form and the Assignment Letter have been updated AND are no longer located as a tab within the rebate application. The 2022 Contractor Participation Agreement is being finalized and will be made available soon when complete. Please continue to work under the 2021 Contractor Participation Agreement. When the agreement is available, you will be notified.
