Site Description

Location: The East Hampton Airport site is located in the Hamlet of Wainscott approximately 2 miles west of the Village of East Hampton on the South Fork of Long Island. The site is comprised of three (3) areas of concern (AOCs). The total area is comprised of approximately 47 acres out of the 570-acre airport property. The 3 locations consist of the area in and around the terminal, the fuel depot, the north end of the runway 34 and west of Daniels Hole Road as one area, the area around the fire training facility and along Industrial Road as the second area, and the area around the separate

structure housing the fire fighting equipment off Industrial Road on the southeast portion of the airport as the third area. The Atlantic Ocean lies to the south. The west is bordered by the Village of Sagaponack, and on the east is the village of East Hampton. Other communities that border Wainscott are the Town of East Hampton, the Village of Sag Harbor to the north and Noyack and Bridgehampton to the west. Site Features: The site features include an airport terminal, Fuel Depot area, parking lot and various other support facilities. Current Zoning and Land Use: The site property is zoned Commercial and/or Industrial according to the Town zoning map. Surrounding properties are used for residential and commercial purposes with areas of open, unoccupied land. The site is currently used for the terminal area and various support structures for a public use airport. Past Use of the Site: Prior to airport construction in the late 1930s, the property was primarily pine barrens with some agricultural uses. Site Geology and Hydrogeology: This is located on the southern coastal plain of Long Island on the Atlantic Ocean. The shallow soils are generally comprised of glacial outwash sands with intermittent non-continuous clay lenses as remnants of the receding Wisconsin ice sheets from the end of the Pleistocene epic.

Site Environmental Assessment

Nature and Extent of Contamination: Sampling for the Site Characterization identified groundwater at/near the facility indicated the presence of perfluorinated compounds (PFCs) at elevated levels which require additional investigation. The area(s) near the terminal, fuel depot and end of the north - south runway and two of the commercial buildings, one being the Fire Training center and the other a firefighting equipment warehouse along Industrial Road had PFAS compounds as high as 290 nanograms per liter (ng/l). Co-located soil sample results corresponding to locations of the groundwater samples ranged from non-detect to 4 ng/g. The elevated levels of Perfluoro Alkyl Substances (PFAS) and are expected to be further characterized during the remedial investigation.

Site Health Assessment

People may contact site-related compounds in soil by digging or otherwise disturbing the soil or groundwater. Extensive sampling of private wells in the area has indicated site-related compounds in drinking water in some wells at levels that represent a health concern. These wells have received treatment systems to address the exposure to the compounds. In addition, a public water supply network is being expanded to service all the homes in the area. Insufficient information exists to sufficiently evaluate all exposures to site-related compounds.

State Superfund Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map on the reverse side of this page, has been added to the Registry as a Class 2 site that presents a significant threat to public health and/or the environment for the following reason(s):

Fire-fighting foam containing per- and polyfluoroalkyl substances (PFAS) was used and stored on the East Hampton Airport during crash response and training. PFAS's including perfluorooctanesulfonic acid (PFOS) and perfluorooctanoic acid (PFOA), have been detected in on-site soil and groundwater and off-site private drinking water wells. The concentrations of PFOS/PFOA in the drinking water supply wells exceed the United States Environmental Protection Agency's (USEPA's) drinking health advisory for PFOS/PFOA, 70 parts per trillion. Actions have been taken to mitigate the presence of PFAS in supplies, however, additional actions are needed to define the nature and extent of contamination in groundwater and other environmental media. DEC will keep you informed throughout the investigation and cleanup of the site.


