

## 2020 Bulk Purchase Rebate Program Product Pre-Approval Form

In an effort to increase the installation of ENERGY STAR® certified lighting products in its service territory, PSEG Long Island is offering a bulk purchase rebate to homeowners, builders, and contractors who install ENERGY STAR certified LED light bulbs and fixtures in residential applications. The bulk purchase program requires this pre-approval form to be submitted prior to purchase in order to participate in this program. Rebate amount is subject to change at any time per PSEG Long Island's discretion.

**All Products must be pre-approved prior to purchase**

- Installation address must be a PSEG Long Island Residential address to qualify.
- Products must be ENERGY STAR certified and currently listed on [www.energystar.gov](http://www.energystar.gov).
  - Please verify product is certified before submitting this form.
- Bulk purchase rebates cannot be combined with any other PSEG Long Island offer; including PSEG Long Island instant markdown incentives at participating retail locations.

**The following criteria must be met in order to qualify for reimbursement:**

- **Bulk purchase sales receipt and/or invoice must be dated on or after pre-approval signature date.**
- Must purchase 21 bulbs or more of the same model number at the same time.
  - LED bulbs/fixtures that are ENERGY STAR certified and that do not receive an in-store PSEG Long Island discount can be submitted for bulk purchase reimbursement. The sales receipt **must** distinctly show that no PSEG Long Island discount has been received on the remaining bulbs.
- Purchases must be made between 1/1/20 and 12/31/20.
- Rebate cannot exceed 80% of retail cost per bulb or fixture.
- **Rebate forms must be submitted within 30 days of the purchase date and cannot be submitted any later than 12/31/20.**
- Products cannot be purchased for resale.
