## Rebate requirements

- ✓ You must be a PSEG Long Island residential customer.
- ✓ You must sign the rebate form (see the green section on the reverse side).
- ✓ There is a **limit of one** rebate per year, per residential account. You must purchase an **ENERGY STAR Electric Heat Pump Clothes Dryer** between January 1 and December 31, 2018.
- ✓ The rebate must be sent in within **45 days of purchase** but postmarked no later than December 31, 2018.
- ✓ The rebate amount cannot be more than 50 percent of the retail purchase price.
- ✓ Electric heat pump clothes dryer model must be on the qualified ENERGY STAR list. For a list of qualified **ENERGY STAR Electric Heat Pump Clothes Dryers**, visit [psegliny.com/efficiency](http://psegliny.com/efficiency).
- ✓ Account service address and installation address on receipt must match to receive this rebate.
