Assignee may not assign this Assignment of Rebate or its rights and obligations hereunder, and any attempt to do so is null and void and has no force or effect.

No modification of this Assignment of Rebate is permitted. Cancellation of this agreement should be noted in Section 2 and contained in a written agreement dated subsequent to the date of this Assignment of Rebate that expressly references this Assignment of Rebate and its intent to modify its terms, and that is signed on behalf of the installer/developer/host, Assignee, and PSEGLI by their duly authorized representatives.

The installer/developer/host and its Assignee agree that if there are arrears on any account that installer/developer/host has with PSEGLI ("Arrears"), PSEGLI shall apply the amount of any Rebate first to those arrears before remitting the balance, if any, to the installer/developer/host's Assignee. The installer/developer/host agrees that PSEGLI's application of all or a portion of the Rebate to Arrears will not reduce the amount that they may owe to its Assignee.
