

In an effort to increase the installation of ENERGY STAR® certified lighting products in its service territory, PSEG Long Island is offering a bulk purchase rebate to homeowners, builders, and contractors who install ENERGY STAR certified LED light bulbs and fixtures in residential applications. The rebate amount is subject to change at any time per PSEG Long Island's discretion. Reimbursement is subject to prior written approval from PSEG Long Island.

All Products must be pre-approved prior to purchase and rebate submittal:

- Approved bulk purchase quantities must be purchased at the same time and listed on the same sales receipt/invoice.
- Installation address must be a PSEG Long Island Residential address to qualify.
- Products must be ENERGY STAR certified and currently listed on www.energystar.gov.
- Bulk purchase rebates cannot be combined with any other PSEG Long Island offer; including all existing PSEG Long Island markdown incentives at participating retailers.

The following criteria must be met in order to qualify for reimbursement:

- **Bulk purchase sales receipt and/or invoice must be dated after pre-approval signature date.**
- Rebate amount per unit cannot exceed 80% of the retail cost per bulb or fixture.
- Must purchase **21 bulbs or more of the same model number** at the same time.
 - Exclusions may apply and will be determined during pre-approval.
- Purchases must be made between 1/1/20 and 12/31/20.
- **Rebate forms must be submitted within 30 days of the purchase date and cannot be submitted any later than 12/31/20 to qualify.**
- Products cannot be purchased for resale.
