Summary of Key Updates:

Below please find the updates made to the application:

- Version \rightarrow 2.0
- Program Year → 2025
- Effective Date \rightarrow 6.2.25
- Eligibility Table Tab Added language that Private Car dealerships are not eligible for incentives
- Eligibility Table Tab Added language that DCFC must have a minimum of at least 100kW for all tiers
- Eligibility Table Tab → Updated Eligibility Tables to reflect \$/Port caps and USMR Caps
