How to Submit Customer Rebate Application Forms

Option 1: Submitting via Email/Mail-In

When submitting rebate forms via email/mail-in on behalf of the customer, please include:

1. 2024 Rebate Form
2. Installation/Final Paid Invoice that includes:
 - Customer's Name and Address of Unit Installment
 - Date of Purchase and Installation
 - Installed Unit Model Number
 - Cost of Unit
 - Proof of Customer's Full Payment
3. Photo of Installed Heat Pump Unit in Customer's Permanent Location
4. Photo of Installed Heat Pump Model Number/ Serial Number Tag on the Unit

Option 2: Submitting via Online Application Portal

When submitting rebate forms on behalf of the customer via PSEG Long Island's Online Application, please follow these steps:

How to Apply for Products:

- Locate your PSEG Long Island Account Number on your bill or through the My Account portal
- Online Purchases require proof of delivery/proof of pickup receipt, or the rebate will be denied
- Scan and upload a copy of your paid in full invoice onto your computer
- Select Rebate Program – Appliances/Equipment
- Begin Online Application





BEGIN ONLINE APPLICATION

 - Check = Check mailed to customer
 - Bill Credit = Rebate credited to customer’s PSEG-LI bill
- After filling out the customer’s information, click ‘Save and Continue.’
 - A ‘Rebate Requirement’ pop up will appear. Click ‘Read the Rebate Requirement.’ This will open on a separate tab.
 - After reading, return to the previous tab and click ‘Agree.’



PSEG Long Island reserves the right to conduct an inspection. Photos of installed equipment and nameplate containing model and serial number may be required.

Please note, for air source heat pump projects a copy of the equipment AHRI certificate must also be uploaded.

The invoice should include:

- Invoice/Receipt Date
- Invoice/Receipt Number
- Place of Purchase
- Quantity
- Appliances
- Purchase Price Paid

The air source heat pump invoice should include:

- Customer name and installation address
- Equipment Manufacturer
- Condenser model number and serial number
- Coil/Air Handler model number and serial number
- Proof of Payment (reflecting total installed cost)

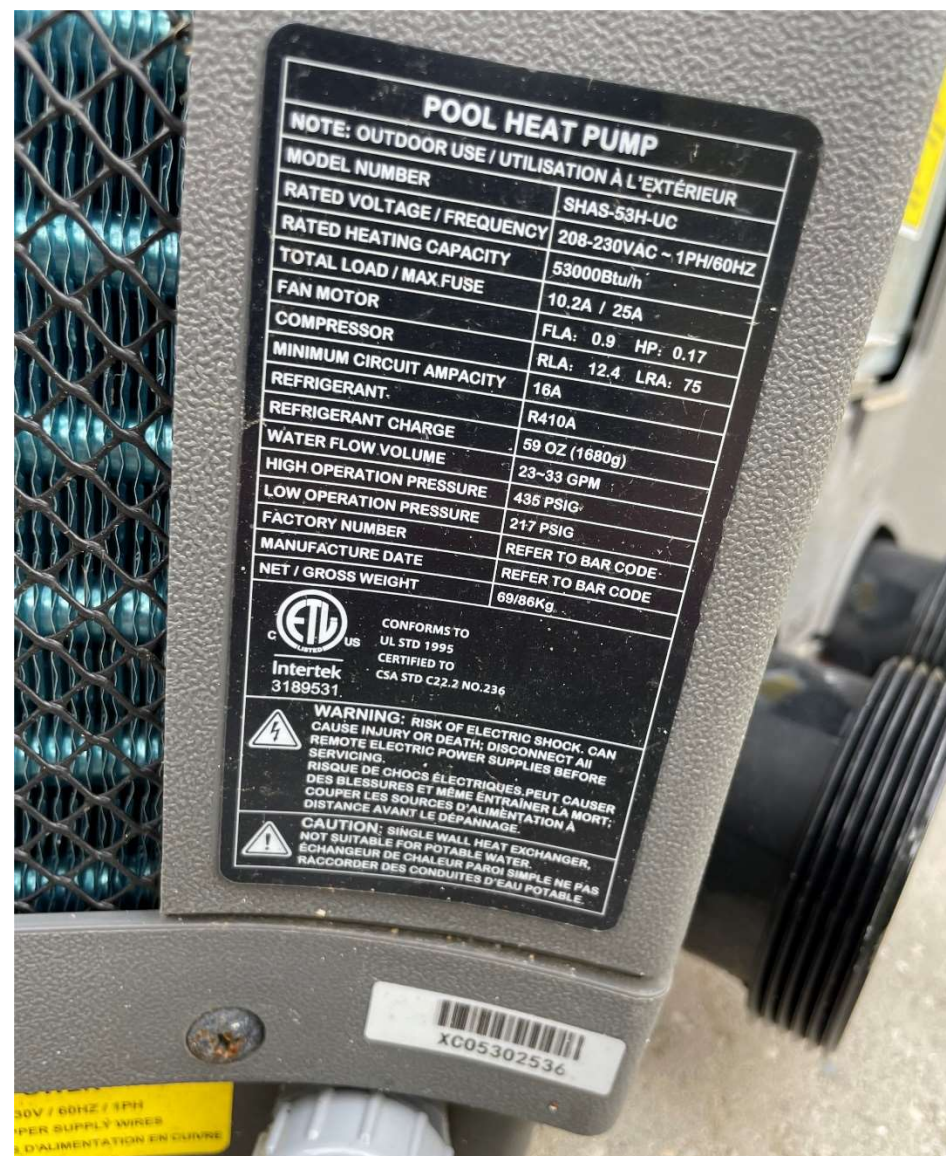
