PSEG Long Island is happy to announce the release of our Energy Efficient Products - ENERGY STAR® Certified Heat Pump Water Heater Partner Program for 2026. To better support our Partners, we will be collecting updated information and required documents to strengthen the relationship with our partners, update relevant dealer/installer information, and provide support for your continued participation in 2026.

- ❖ Participation in a prior year does not carry over. All partners must apply again to be eligible for 2026 rebates and incentives.
- ❖ If you were a prior partner re-enrolling for 2026 under a different program, please disregard this message.

Effective January 1, 2026, PSEG Long Island will continue to offer customers rebates of up to \$1,200 for installations of Heat Pump Water Heaters. The program will provide a **\$150 partner/dealer/installer incentive** for all eligible completed installations.

PSEG Long Island provides customer rebates and partner incentives for the following:

- ENERGY STAR® Certified Heat Pump Water Heater – limit of one electric heat pump water heater per residential customer account every 5 years. The Qualified Product List can be located [here](#).
