RE: 2023 Home Comfort and Home Performance Program Application Version 4.0 Release

Dear Home Comfort and Home Performance Partners:

PSEG Long Island is pleased to release the 2023 Home Comfort and Home Performance V4.0 rebate application workbook. Effective Friday, September 15th by close of business (COB), all new project submittals must use the V4.0 application. The application will be available for download at <u>https://www.psegliny.com/en/saveenergyandmoney/homeefficiency/HomeComfort/Contractors.</u>

In addition to the new application, PSEG Long Island is also making some significant changes to the Home Comfort/Home Performance Program regarding Partial House projects. <u>No changes were made to Whole House Rebate levels or process</u>. The changes to Partial House are:

- Partial House rebates are no longer available and have been removed from V4.0
 - Contractors or customers installing partial house projects may complete the online or paper application for a rebate of \$250.00 per outdoor unit.
 - Maximum of 2 outdoor units per application.
 - Limit of 1 application per account for every 5-year period.

- Requirements for On-Line Application:
 - Ductless Air Source Heat Pump SEER ≥18 & HSPF ≥8.5
 - Ducted Air Source Heat Pump SEER ≥15 & HSPF ≥8.5
 - Does NOT have to be NEEP listed
 - Manual J is NOT required
- For Partial House systems, all V3.0 rebate applications for completed projects must be submitted by COB September 15th.
 No V3.0 applications will be accepted after that time.
- REMINDER: All invoices must clearly state "PAID IN FULL" or show a zero balance or they will be rejected
- Whole House Rebates: No changes

All projects must be installed, completed, and required documents submitted no later than COB Friday, September 15th to qualify for current processing rules, rebates and incentives.
