 - Whole-House Projects (Market Rate): Total rebates will not exceed 70% of total project cost OR \$5,000 in total rebates, whichever occurs first.
 - Whole-House Projects (Income Eligible Rate): Total rebates will not exceed 100% of total project cost OR \$11,000 in total rebates, whichever occurs first.

2024 Geothermal Rebate Application Version 1.0:

- o Rebates updated to calculate based on heating tons instead of cooling tons.
- Whole-House Projects (Market Rate): Total rebates will not exceed 70% of total project cost OR
 \$25,000 in total rebates, whichever occurs first.
- Whole-House Projects (Income Eligible Rate): Total rebates will not exceed 100% of total project cost
 OR \$35,000 in total rebates, whichever occurs first.
- o Added clarifying language regarding Open Loop Systems and additional requirements.

Unless indicated above, there are no additional changes to rebate levels.
