RE: 2020 Home Comfort and Home Performance Rebate Application Version 1.1 Release

Dear Home Comfort Partners:

PSEG Long Island is excited to announce several new enhancements to the 2020 Home Comfort Program offerings now available to both you and your customers. These enhancements have been incorporated into the latest release of the application. The application is now available for download at https://www.psegliny.com/saveenergyandmoney/homeefficiency/homecomfort/contractors

The new application incorporates measures from our Home Performance Program. Home Performance Partners who are also Home Comfort Partners can now submit one single application for HVAC as well as weatherization rebates.

Participating Home Comfort Partners can now offer enhanced rebates to income eligible (low moderate income LMI) customers and provide potential financing options for eligible projects with the NYSERDA Green Jobs – Green New York funding through Energy Finance Solutions/Slipstream.

Home Comfort partners also need to become a participating contractor directly with Energy Finance Solutions (EFS) in order to be eligible to extend this service. To become an EFS participating contractor, please visit http://www.energyfinancesolutions.com/forcontractors-documents-forms.

We are extending our whole-house solution (per-ton rebate) to the rest of our heat pumps offerings. Projects that do not qualify under the whole house solution may now be eligible for our partial house rebates.
