#### **RE: 2026 Home Comfort and Home Performance Program and Application Version 1.0 Release**

PSEG Long Island is pleased to announce the 2026 Home Comfort & Home Performance Program V1.0 application workbook. This workbook is effective December 22, 2025. Please note that projects sold and completed in 2025 must be submitted by COB of December 31, 2025, utilizing the 2025 application and under 2025 requirements. All applications submitted on/after January 1, 2026, must use the 2026 application and are subject to the 2026 program requirements.

CHANGES to the Home Comfort Program for 2026 (effective December 22, 2025) include:

- A new rebate income tier category “Moderate Income” (60% Area Median Income (AMI)) level has been added. Rebates for this tier are capped at \$5,625/project.
- Manual J heating load must be 100-120% of the maximum heating capacity at 17°F.
- Rebates levels are capped at five heating tons.
- Ground source heat pump rebates are now incorporated on the same application.
- Ground source heat pump rebates are now \$2,400/heating ton (market rate) and \$4,800/heating ton (low income) for new installation. For retrofit, the ground source heat pump rebates are now \$1,200/heating ton (market rate) and \$2,400/heating ton (low income). Rebates are capped at \$12,000 (Market Rate, new installation), \$24,000 (Low Income, new installation) \$6,000 (Market Rate, retrofit) and \$12,000 (Low Income, retrofit).
- Contractor incentives for ground source heat pump are \$500/project (new installation) and \$200/project (retrofit).
- NEEP listed ccASHP with furnace component are no longer eligible.
- A bonus rebate for decommissioning of existing fossil fuel systems has been added - \$250/project (for ccASHP/AWHP projects only).

Changes to the Home Performance Program 2026 (effective December 22, 2025) include:

- Home Performance rebates are updated for 2026 as follows:

Insulation	\$2,500	\$3,125	\$5,200
Air Sealing	\$1,000	\$1,250	\$2,000
Duct Sealing	\$500	\$625	\$800
Windows*	\$4	\$4	\$8
