# RE: 2024 Home Comfort and Home Performance Program and Application Version 3.0 Release

PSEG Long Island is pleased to announce the 2024 Home Comfort & Home Performance Program V3.0 application workbook. The new application has an added tab for **air to water heat pump incentives** and **increased Home Performance with Energy Star rebates**. The application is effective April 1, 2024. Units must be installed after April 1, 2024. We will continue to accept the V2.0 application until COB of April 15th.

Updates made to the Home Comfort and Home Performance Version 3.0 include:

### AWHP Equipment Info Tab:

- New Tab for Air to Water Heat Pump Rebates
  - Tab operates similar to the ASHP Equipment Info Tab
  - The rebate structure is the same as the ASHP structure
    - Rebates for Air to Water Heat Pumps are based on the Heating Capacity as defined by the New York State AWHP Qualified Product List
- The QPL is integrated into the workbook The Partner will selected MFG and Model Number, all other efficiency details will auto populate
- o AWHP Rebate is for existing buildings only
- Integrated Controls are not required at this time
- Equipment must be sized to 100-120% of the heating load

# • Home Performance Tab(s):

- On all applicable tabs, all "Natural Gas customers are not eligible" language has been removed and will be added back when National Grid resumes its program
- Insulation portion of tab has been updated to include a 6th data entry table
  - Additional "location attributes" have also been added for Attic/Attic 2 scenarios
- Home Performance Rebates have been updated per the below:
  - Market Rebates remain the same
  - Market Rebates for customers located in a DAC has been increased by ~25%



- This rebate will appear if Partner selects "Yes" on new DAC field on the Customer Information Tab
- Low Income/Low Income DAC Rebates have been increased by ~25%
  - Low Income or Low Income customers located in a DAC rebates are the same
  - In order to qualify for the Disadvantage Community rebates, all closing documents must be received by November 1, 2024.
