RE: 2019 Cool Homes Rebate Schedule and Application Release

Dear Cool Homes Partners:

PSEG Long Island is happy to announce the 2019 Cool Homes rebate schedule and application. We will continue to accept 2018 applications through January 11, 2019. We will not accept applications from prior years. These rebate/incentive levels and efficiency criteria apply to all systems installed on or after January 1, 2019.

For 2019 we are also offering three new rebates - \$450/system rebate for ducted split cold climate heat pumps, \$350/system rebate for ductless mini-split cold climate heat pumps and \$100/system for packaged terminal heat pumps. Cold climate heat pumps must be on Northeast Energy Efficiency Partnership Cold Climate Heat Pump Specification Product Listing to be eligible - not all cold climate heat pumps listed are eligible. The 2019 Residential CAC Rebate Application form is now available and can be located at https://www.psegliny.com/saveenergyandmoney/homeefficiency/coolhomes/coolhomespartner.

For eligible systems installed on or before December 31, 2018, you will have until January 11, 2019 to submit all required documentation in order to be eligible for 2018 rebate levels. For any projects missing airflow and charge results, continue to submit documentation before January 11, 2019 and you will be granted the customary allowance until June 30, 2019 to submit the missing airflow and charge results. We will no longer accept 2018 applications after January 11, 2019.

The contractor incentive is now tiered for the first ducted split central air conditioner (CAC) or air source heat pump (ASHP) system and \$50 for additional system for the same customer account.
