RE: 2024 Home Performance Program Update

PSEG Long Island is pleased to announce that all National Grid customers who heat their homes with Natural Gas are once again eligible to receive Market Rate Home Performance Program Rebates from PSEG Long Island. This change will be effective from February 2, 2024, to November 1, 2024. You can continue to use the existing application to submit these projects!

The rebate structure is the same regardless of fuel type. See below:

Insulation (attic, wall, floor, band joist, basement, crawl space)	Must be accompanied by blower door assisted air sealing per BPI standards	
Air Sealing	Blower door assisted per BPI standards	
Duct Sealing	UL 181B mastic or tape; use of "duct tape" is disallowed	
Windows	0.2- 0.32 U- Factor
